## SUMMARY OF OUTREACH FOR STORMWATER UTILITY PROGRAM DEVELOPMENT

- Public Works staff presented to City Council information on the Municipal Separate Storm Sewer
   System (MS4) Permit Program and on funding proposals on:
  - October 29, 2013 City Council Work Session The Municipal Separate Storm Sewer Systems (MS4) Program
  - November 26, 2013 City Council Meeting Established Stormwater Advisory Committee and adopted bylaws
  - September 23, 2014 City Council Meeting Update on Stormwater Advisory Committee (SWAC) activities and draft Utility Ordinance
  - October 11, 2014 Presentation of Proposed Stormwater Utility Ordinance and Fee
- Stormwater Advisory Committee (SWAC) met once per month. Meetings are open to the public and include a public comment period at the beginning.

- Between September 2014 and January 2015, city staff and SWAC members presented at 15
  meetings with colleges, churches, residential and commercial property owners/ managers, business
  organizations, rotary clubs, builders associations, and special interest groups.
- Two (2) open houses on November 12 at Thomas Harrison MS and December 2 Spotswood ES that ran from 5:30pm-7:30pm. 17 people attended on November 12 and over 40 people attended on December 2.
- A public comment period was advertised between November 12 through December 20. Between September 29 through December 20, 42 individuals submitted comments. (See enclosed summary and full comments.)
- The February 24, 2015 Public Hearing was advertised on February 9 and 16, 2015 in the Daily-News Record.
