Please note that we do not have the authority to inspect or enforce matters with mold and other contaminants. Harrisonburg does not have a rental inspection program.

✓ <u>Septic to Sewer Conversion Financial Assistance Program</u>: Financial incentives and fee waivers for residences with septic systems that undergo conversion to public sewer system.

CITY OF HARRISONBURG PUBLIC WORKS • 540-434-5928

- ✓ <u>Conservation Assistance Program</u>: Cost share reimbursement program to assist eligible property owners with water quality improvements. Funds may cover costs to plant trees.
- ✓ Residential Credit Program: Partial reduction in residential stormwater utility fee.
- ✓ Assistance taking out trash or help shoveling snow for households physically unable to do so
- ✓ <u>Solar Energy Resources</u>: Information on permits, easements, local real estate tax exemptions, and links to guidance on federal tax credits.
- ✓ <u>Environmental Initiatives</u> details city efforts and external resources. For example, Virginia has an income tax deduction for sales tax paid on certain energy efficient equipment and appliances, and sales tax on certain Energy Star and WaterSense products are waived during Virginia's annual sales tax holiday (<u>www.tax.virginia.gov/virginia-sales-tax-holiday</u>).
