HDPT looks at next decade of transit service with strategic plan

Community input needed to strengthen transit operations in Harrisonburg

HARRISONBURG, Va. – The Harrisonburg Department of Public Transportation is seeking community input on how to strengthen transit service in The Friendly City as it creates its next 10-year Transit Strategic Plan.

The plan, which is required for transit agencies that service urbanized areas in Virginia to ensure they meet the mobility needs of the community, will be informed by feedback gathered throughout November. An engagement pop-up event was held Saturday, Oct. 28, at the Harrisonburg Farmers Market, with additional popups scheduled for Nov. 1 and 2 around the community *(see attached image for more)*.

Additionally, an online survey for riders and non-riders is available at <u>https://harrisonburgva.gov/bus-service</u> where people can provide input on how HDPT can best serve their needs, and paper copies are available at Harrisonburg City Hall (409 S. Main St.) and HDPT's offices (475 E. Washington St.).

Community input is invaluable to the process, as the needs of riders and potential riders will help identify ways HDPT can grow and improve.

"The survey and pop-ups are open for all in our community – if you currently use HDPT's services, we want to know how to make them better for you; if you don't ride, we want to know how we can make it easier for you to do so," HDPT Director Gerald Gatobu said. "The feedback we receive from you in the coming days will play a large role in determining how we provide public transportation in Harrisonburg for the next decade. We hope everyone will use this opportunity to help us ensure we are providing equitable, safe and reliable service that improves quality of life in our

TSPs are required for transit agencies that serve urbanized areas in Virginia to ensure they meet the mobility needs of the community.
 The TSP has four overarching goals which will guide service changes and development:
 Provide an equitable, safe, and reliable transportation service

- 2 Improve quality of life and foster economic growth
- 3 Foster connections with local and regional partners
- Prioritize exceptional customer service

We are committed to engaging the community in the planning process. In the month of November there will be multiple opportunities to provide input both online, through a survey, and in-person, at one of four pop-up events. Pop-ups will be held on:

- 11/1 at Harrisonburg Crossing/Walmart from 1–3pm Harrisonburg Crossing—Bus Shelter by Walmart Gas Station
- 11/2 at Gay St Transit Hub from 10am–12pm Gay St Transit Hub–Corner of East Gay St & Community St
- 11/2 at JMU Godwin Transit Center from 1–3pm JMU Godwin Transit Center—By JMU Bookstore & Goodwin Hall
