1. Question: I have noticed that you are asking for one lump sum on the bid form but on page DTS - 34 in reference to item # 10 Signs and logos, it states that the logo is an alternate bid item that is listed as bid number item 6. I don't see any reference to alternate items on the bid forms. Can you provide clarification?

Answer: The BID FORM has been updated and expanded to include the lump sum base bid work as well as unit rates for potential additional work. Line #9 has been added for bidders to submit a cost for each of two signs / logos per Section J.10 of the Detailed Technical Specifications. Award of sign / logos will be dependent upon available funding.

2. Question: The bid form provided only has one line to write in lump sum price, but the TIC section of the book lists different bid items and alternate bid items. Is there supposed to be a different bid form for us to fill out? Is this a prevailing wage or a Davis-Bacon Wage job?

Answer: The BID FORM has been updated and expanded to include the lump sum base bid work as well as unit rates for potential additional work. Line #9 has been added for bidders to submit a cost for each of two signs / logos per Section J.10 of the Detailed Technical Specifications. Award of sign / logos will be dependent upon available funding.

This project is not subject to prevailing wage or Davis-Bacon wages.

All other requirements, terms and conditions of the ITB/RFP remain unchanged.
