- 4. The Electoral Board Meeting of Tuesday, March 5, 2024 was called to order at 6:00 am in the Registrar's Office, for the purpose of conducting the Dual Primary election.
- 5. The Elector Board Meeting of Wednesday, March 6, 2024 resumed in the Registrar's Office, with Provisional Ballot Hearing that started at 12:00 pm.
- 6. The Electoral Board resumed on Friday, March 8, 2024.
- 7. The Electoral Board resumed on Saturday, March 9, 2024 at 2:00 pm and adjourned at 4:30 pm, wherein the Election Process was certified.
- 8. All members of the Electoral Board agreed to meet on Monday, March 11, 2024. On that date the Electoral Board Members, along with the General Registrar, Equipment Technicians, and an employee of the County Supervisor's staff secured documents from the Dual Primary of March 5, 2024, and then the General Registrar carried other documents to the County Clerk 's Office at the Courthouse.
